## F) FUEL INFORMATION

- Fuel (JET A-1 / AVGAS 100LL) is supplied by **CARBOIL Srl**.
- The fuel farm is open daily from **06:00LT** to **22:00LT**.
- Fuel can also be available outside normal opening hours, from **22:01LT** to **05:59LT** if agreed in advance with a fax request to be sent no later than 2 hours (i.e. 20:00LT) before the closure time of the fuel farm.
- Fuel can be paid by a selection of resellers cards: BP, UVAir, World Fuel Services, AVcard, Aloa, Nautilus. Avgas only can be paid by credit/debit card (Moneta, Visa, Visa Electron, PagoBancomat, Maestro, MasterCard, EuroCard, Agos, JCB Cards; DINERS and AMEX are NOT accepted).
- Cash payments are allowed **up to 999 EUR** only.

## **G) ACCOUNTING and SETTLEMENT PROCEDURES**

The form of payment must be agreed in writing by the parties before the date of the flight.

a) Payments must be made by credit card before the departure of their aircraft and must be referred to all services received, in accordance with the invoice issued by Aeroporto Friuli Venezia Giulia S.p.A..

b) For payments in foreign currency, the equivalent amount in EURO (EUR) will be calculated on the basis of the official daily rate of exchange.

c) Payment of third party suppliers (i.e. the fuel company, the catere, etc.) must be separately arranged with those companies.

### **REMARKS:**

1) *The aircraft weight, expressed in metric tons, is the maximum take-off weight (MTOW) resulting from the flight certificate. Fractions of ton are rounded up to the upper unit.*
